BE IT ENACTED by the City Council of the City of Winthrop, Iowa:

SECTION 1. CHAPTER MODIFIED. Chapter 99, Section 99.02, of the Code of Ordinances of the City of Winthrop, Iowa, is repealed and the following adopted in lieu thereof: Chapter 99
